**REFUND & WINDRAWAL POLICY**

Refund requests must be submitted at least three (3) days prior to the start of the programme. No refunds will be provided once the programme has begun, except in cases of grave illness or emergency, subject to approval. This request, however, can only be made in the first week of summer school **Students who cease attending classes without formally notifying the College in writing will be deemed to have withdrawn without notice. Such students forfeit their registration and are not entitled to a refund under the Colleges refund policy. Re-enrolment in a subsequent semester will require a new application, approval, and payment of applicable fees.**

**CANCELLATION**

Any course can be cancelled due to insufficient enrollment or other unforeseen circumstances. All applicants will be notified and refunded where applicable without penalty however, the school may consider delaying the start of the class for two (2) weeks to allow for additional registration of students for course.

**CARE CENTRE SERVICE**

- Please be advised that the College provides a Care Centre service from 3:00 P.M. – 6:00 P.M. during Summer School at a cost of \$600. Thereafter, this service attracts an additional charge of \$300 per hour or part thereof. This fee is payable at the point of pick up from the Care Centre each day.
- Children who are not collected by 3:00 PM will be sent to the Care Centre whether their parents subscribed to the service or not. Please note that once your child has been sent to the Care Centre, the applicable fees are charged to that child’s account.

**MEDICAL SERVICES**

The services of a nurse are available at the college for any injuries and other minor medical conditions. The college will not take responsibility for the purchase of medical prescriptions in the case of medical treatment at a doctor’s office where accidents or injuries occur on the campus. **Please complete the section on the form overleaf that speaks to illnesses.**

- Children are only allowed in authorized areas. Socializing is accepted in all general spaces except for bathrooms, secluded spaces or in areas designated as “Out of Bounds”;
- Please mark clearly and visibly all your child(ren)/ward(s)’s belongings with their full name;
- A lost and found station will be set up in each School and items can be collected from the relevant coordinators.
